What does this form do?

Updates the personal, family and share information.

When will this form be used?

This form is used when there is a change in you, your family or your share information.

How will this information be used?

The information here will be used to maintain accurate information for the shareholder, to be used to keep the certificate, relatives that may inherit shares and contact information accurate.

What other information will be required with this form?

There is no other information required.

How do I fill this form out?

Part 1 is your personal information, name, address, date of birth, etc. Also the information about your parents, and spouse

Part 2 is information about the shares you own, the certificate number, number of shares and how you received them.

Part 3 is information about your children that may some day inherit.
