## INSTRUCTIONS

### Affidavit Concerning Lost, Destroyed or Mutilated Shares Certificates

***What does this form do?***

To ask and receive replacement certificates due to lost, destroyed, or mutilated Tetlin Native Corporation Share Certificates.

***When will this form be used?***

This form is used when certificates are lost, stolen, damaged or destroyed and need to have them replaced.

***How will this information be used?***

The information from this form will be used to confirm the legitimate owner of the shares, that the certificates need replacing, and confirm the right certificates.

***What additional information will need to be sent in with this form?***

Any remnant of the original certificates.

***How do I fill out this form?***

**Part 1:** Shareholder requesting replaced certificates. This gives information about the one asking for replacement, and whether they are the legitimate owner of the shares

**Part 2:** Description of certificates: gives any information that will help to identify the right certificates. Don't forget to include any remnant of the certificates that you have with this form.

**Part 3:** What happened to the original certificates? If anyone else saw what happened, let us know who they are. We will want to contact them.
